



RECOGNIZED PUBLICATION ETHICS AND MALPRACTICE STATEMENT

The *Romanian Journal of Rhinology*, the official journal of the Romanian Rhinologic Society, publishes original clinical reports and clinically relevant experimental studies, literature reviews, as well as case reports and short communications presenting new results of special interest. Founded in 2011, the journal aims to concentrate and provide information concerning care, cure and prevention of different rhinologic disorders. With a peer review by an important national and international editorial board, the journal provides clinical and clinically related information written by authors from all over the world.

We uphold the best standard of publication ethics and take all possible measures against publication malpractices. It is therefore important to agree upon standards of expected ethical behavior for all parties involved in the act of publishing: the author, the journal editor, the peer reviewer, the publisher and the society.

PUBLICATION AND AUTHORSHIP

Publishers should protect and respect the privacy of authors, editors, peer-reviewers, protect the intellectual property and copyright.

Publishers as well as authors are forbidden to publish articles with similar results in more than one journal.

Each article should have a references list and state, if the case, the financial support.

All authors should read and sign the statements from the authorship responsibility, criteria and contributions form.



AUTHOR'S RESPONSABILITIES

Articles are published only after the authors agree to transfer all copyrights to ***Romanian Journal of Rhinology***.

The authors should warrant the full originality of their work. If they have used the work/words of another author, this has to be cited or quoted. Also, the authors should not submit manuscripts that have been published in the same form in other journals. If papers closely related have been published elsewhere or presented in different scientific meetings the author must state this when submitting the article.

The authors should state that each author of the article has participated (design, drafting, data acquisition, data analysis and interpretation, statistical analysis, etc.) in the work represented by the manuscript to take public responsibility for the content.

Authors of original articles or researches should present an accurate account of their results, as well as an objective discussion of its significance. The paper should contain sufficient details to permit its quotation by other authors.

If an author discovers errors or inaccurate data in his/her manuscript, it is the author's obligation to inform the editor and to withdraw or correct the paper.

The authors have the right to present the published articles at conferences or congresses.

All authors must disclose any financial or personal relationship with people or organizations that could inappropriately influence their work. All sources of financial support have to be mentioned.

The manuscript submitted for publication must contain a statement that the human studies have been performed in accordance with the ethical standards laid down in an appropriate version by the 1964 Declaration of Helsinki. Reports on animals' experiments must state that the "Principles of laboratory animal care" were followed.



Proper acknowledgment must be given. The authors have to mention any publication, person or law that have influence the nature and the results of their work.

REVIEWERS RESPONSABILITIES

Reviewers should not assess papers susceptible of conflict of interest resulting from collaboration or any other relationship with the authors.

The reviewer has to be objective, personal criticism being inappropriate. He/She should sustain their viewpoints with solid arguments.

Reviewers have to identify relevant publications not cited by the author and notify any similarity with other published article.

In case of unpublished materials this should not be used by the reviewer in his/her benefit without the written consent of the author.

All reviewers must treat each article confidentially.

EDITORIAL RESPONSABILITIES

The editor of the *Romanian Journal of Rhinology* can decide which of the article submitted to the journal should be published. Journal's editors should have no conflict of interest with respect to articles they accept or reject.

The editor has to follow journal's policy in matter of copyright and plagiarism.

Editors should ensure that the research material they publish in the Journal conforms to internationally accepted ethical guidelines.

The journal's editor should evaluate the manuscripts for their scientific content no matter the race, nationality, religious beliefs, gender or sexual orientation of the authors.

The editor may give information about the manuscript content only to the author, reviewers, publisher or other editorial advisers.

The editor has to take into consideration any unethical publishing behavior even it is reported or discovered years after publication.

Editors must preserve the anonymity of all reviewers.

PUBLISHING ETHICS ISSUES

The editorial board has to monitor the publishing ethics for each and every article that is submitted and accepted for publication in the journal. Also they have to maintain the integrity of the academic record.

The editorial board has to follow journal's policy in matter of copyright and plagiarism, before publishing an article.

The editorial board should always be willing to publish corrections, clarifications, retractions and apologies when needed.
